Visiting Animals at West Ranch

The information here should prepare you for bringing your alpaca to West Ranch to West Ranch for boarding or breeding. Please know that the requirements laid out in this memo are designed to protect both your animals and those already living at West Ranch.

Please read and sign at the bottom indicating your agreement.

1. All animals will have health certificates including the following – lice check, fecal check and prebreeding exam if maidens.
2. All animals will be current with all vaccinations and worming medications and a copy of recent health records must be provided to West Ranch.
3. All animals will be insured and will have to provide a certificate of insurance. If an animal is not insured the owner must provide a signed letter stating that insurance coverage has not been chosen and that West Ranch is released of any liability.
4. All animals over one year must be registered and will provide a copy of the registration or in the case of a pending application, a copy of the application.
5. All animals over one year must be halter trained. Owner will retain halter and lead after delivering animal(s) to West Ranch.
6. If animals arrive after May 1, they must be shorn prior to arrival.
7. The breeding fee includes 40 days boarding at West Ranch for both dam and cria. After 40 days, the owner will be charged at the regular daily rate for boarding at West Ranch.
8. All veterinary care will be administered by our local vets – Dr. David Jensen DVM and Dr. Carl Zaboly DVM – and will be charged to the owner. For any medical emergencies, we will seek immediate care and will alert the owner as soon as possible but not at the jeopardy of the animal's health. All vet bills associated with animals visiting or boarding at West Ranch are the responsibility of the animal owner and will be billed accordingly. Payment for veterinary care must be made within 30 days of billing.
9. All animals must have name tags when they arrive and if they do not have a name tag, West Ranch will provide a name tag and the cost will be charged to the owner.
